a) Approve Z-031 Text Amendment to permit gas stations for parcels fronting Highland Road (M-59) in the HS, Highland Station Business District and to establish regulations regarding same

Ms. Frederick moved to approve Z-031 Text Amendment to permit gas stations for parcels fronting Highland Road (M-59) in the HS, Highland Station Business District and to establish regulations regarding same. This is an ordinance to amend the Charter Township of Highland Zoning Ordinance (Chapter 25 of the General Code of Ordinances) by revising Article 4, District Regulations to allow for gas stations and drive thru windows for HS, Highland Station Business District with special approval; Article 9, District specific provisions to modify signage regulations for highway oriented business in HS District; Article 10, Supplemental Use Regulations to provide regulation relative to gas stations on

highway oriented parcels in HS District; and Article 13, Lighting to add regulations regarding canopy lighting. Mr. Howe supported, and the motion carried with the following roll call vote: Hamill – yes, Flowers – yes, Frederick – yes, Cooper – yes, Howe – yes, Lewis – yes, and Salvia – yes.
