This Agreement, made and entered into this \_\_\_\_\_\_day of \_\_\_\_\_\_, 2023, by and between the Board of County Road Commissioners of the County of Oakland, Michigan, hereinafter referred to as the BOARD, and the Charter Township of Highland, hereinafter referred to as HIGHLAND, provides as follows:

WHEREAS, the BOARD and HIGHLAND have agreed to program the spreading of gravel and chloride on various county roads under the jurisdiction of the BOARD, as described in Exhibit "A", attached hereto, and made a part hereof, the roads selected will be mutually agreed upon by the BOARD and HIGHLAND, which are hereinafter referred to as the PROJECT; and

WHEREAS, the estimated total cost of the PROJECT is \$116,723; and

WHEREAS, the PROJECT involves certain designated and approved Tri-Party Program funding in the amount of \$116,723 which amount shall be paid through equal contributions by the BOARD, HIGHLAND, and the Oakland County Board of Commissioners, hereinafter referred to as the COUNTY; and

WHEREAS, HIGHLAND and the BOARD have reached a mutual understanding regarding the cost sharing of the PROJECT and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, it is hereby agreed between HIGHLAND and the BOARD that:

1. The BOARD shall forthwith undertake and complete the PROJECT, as above described, and shall perform all engineering, inspection and administration in reference thereto.

- The actual total cost of the PROJECT shall include total payments to the contractor. Any costs incurred by the BOARD prior to this agreement date shall be allowable.
- 3. The estimated total PROJECT cost of \$116,723 shall be allocated as follows:
  - a. Tri-Party Program funding in the amount of \$116,723.
  - Any PROJECT costs above the Tri-Party Program funding of \$116,723 will be funded first with any available Tri-Party Program funds. If no Tri-Party Program funds are available, any PROJECT costs above \$116,723 will be funded 100% by HIGHLAND.
- Upon execution of this Agreement, the BOARD shall submit an invoice to HIGHLAND in the amount of \$38,908 (being 100% of HIGHLAND'S Tri-Party contribution).
- 5. Upon execution of this agreement and approval by the COUNTY, the BOARD shall submit an invoice to the COUNTY in the amount of \$38,908 (being 100% of the COUNTY'S Tri-Party contribution).

Attached is the RCOC's annual letter requesting Highland Township to participate in the 2023 Dust Control Program.

Prices will remain the same in 2023 as they were in 2022 at a cost of \$0.03645 per linear foot. I recommend the Board consider continuing with the Oakland County Dust Control Program for 2023 with 5 blanket applications. Important note EGLE has made revised changes that could affect the dust control program by:

- · Applications would be limited to 4 per season
- The application rate would be reduced significantly
- No brine would be applied to gravel roads within 100ft of surface water

RCOC and other organizations are explaining to EGLE the ramifications of the new rules and the effects it will have on residents who live or drive on gravel roads.

I would also like the Board to consider continuing with our private road reimbursement. The reimbursement would be \$0.30 per lineal foot or 50% of the total bill; whichever is less.

The Road Commission for Oakland County (RCOC) will be offering its dustcontrol program again this season. Enclosed you will find the 2023 Application Form and Instructions that we send to our previous year customers. If your township plans to participate financially in the dust-control program, a letter confirming the amount of township participation must be received by the RCOC Department of Customer Services - Waterford Office no later than April 10, 2023. Unless this letter is received, we will assume the township is not participating in the 2023 Program.

The dust-control program will run again as it did last year, with pricing being applied per application. RCOC will hold the 2022 cost per application for the 2023 season, as illustrated on the table below. Townships that wish to cover all local and subdivision streets will get the "blanket coverage" rate while individual locations will receive the "individual" rate. This pricing allows the customers the option of selecting the best program to meet their needs.

- The application rate is 2,000 gallons per mile per application.

## **BLANKET ORDERS:**

- Cover all local roads and subdivision streets township-wide
- The application rate will be 2,000 gallons per mile per application

# Potential changes to the Dust Control Program

On February 13, 2023, EGLE shared a revised draft of the State of Michigan, Department of Environment, Great Lakes, and Energy Groundwater Discharge General Permit. (General Permit NO. GW1550000) The revised changes that could affect the dust control program are as follows:

- Applications would be limited to 4 per season.
- The application rate would be reduced significantly.
- No brine would be applied to gravel roads within 100 ft of surface water.

The Road Commission for Oakland County (RCOC) wanted to make you aware of these potentially critical changes to the Dust Control Programs while considering the preferred schedule for your Dust Control Program.

RCOC is also working with the County Road Association and others to explain to EGLE the ramifications of the new rules and the effects it will have on residents who live or travel on gravel roads.

  - The attached form must be completely filled out and submitted by mail to the Road Commission for Oakland County, Department of Customer Services, 2420 Pontiac Lake Road at County Center Drive West, Waterford Township, Michigan 48328. Please check with your township to find out if your application should be placed there <u>or</u> with the Road Commission.
  - The cost of dust control treatments will be \$0.1266 per linear foot per application for individual orders of <u>four</u> applications. Pricing has remained the same, as illustrated on the table below:

 Some townships participate in the cost of dust control so <u>please check with your township</u> office regarding their participation as it may change from year to year.

Additional requirements are as follows:

- Description of the road to be treated must include township, road name, linear footage and EXACT location of starting and ending points. Orders without this information will be returned and must be resubmitted by April 24, 2023.
- 2. Orders must be for at least 1,000 consecutive linear feet of dust control with the following EXCEPTIONS:
  - a) Where there is more than one short subdivision street (under 1,000 feet) we will accept orders where the combined footage is in excess of 1,000 feet provided the streets adjoin one another.
  - b) Orders for less than 1,000 feet in subdivisions will be accepted provided the full 1,000 foot payment is made, i.e. \$506.40 for four applications.
  - c) On local "mile type" roads, orders will be accepted for a minimum of 500 feet with no more than one skip. Orders greater than 500 feet will be limited to two skips. This does not apply to subdivision streets.
- 3. Only ONE check should be sent to cover each order. Make the check payable to:

- 4. To avoid delays in processing your order, please make sure you have coordinated your order with orders being placed by your neighbors (connecting orders).
- 5. Private roads cannot be included in this program.

# **APPLICATION SCHEDULE**

Our goal is to have the first application completed by approximately the last weekend of May. Subsequent applications will follow every 4-6 weeks. Please note: The timeframe between applications may vary due to unforeseen circumstances such as weather, equipment breakdowns, material supply and other factors.

### DUST CONTROL MATERIAL

The dust control material that is spread will be mineral-well brine (naturally occurring salt water – see below for more details about the brine used) at an application rate of 2,000 gallons per mile. The width of the application will be 20 to 22 feet. <u>No special width or double applications will be provided</u>. Intersections and extremely wide roads will not be fully covered. Due to our spreading schedule, it is necessary to limit the number of applications to four.

# FACTS ABOUT MINERAL-WELL BRINE

- 1. Mineral-well brine attracts moisture from the atmosphere and the ground. It is this moisture which acts as a binder on the "fines" in the surface aggregate, preventing them from becoming airborne.
- 2. Periods of minimal rainfall and low humidity will result in less moisture attracted to the surface of a gravel road on which mineral-well brine has been applied. As a result, the effectiveness will be less during these periods than during periods of high humidity and more rain. The amount of moisture attracted determines how effectively the dust is controlled. During dry periods, the application may be light in color or appear to be streaked.
- 3. A number of conditions are detrimental to the effectiveness of mineral-well brine with high traffic volume being the foremost. Sandy soil, lack of binders in the gravel and lack of shade trees all have some adverse affect on mineral-well brine.
- 4. We do not accept applications for mineral-well brine on roads which have been oiled. Mineral-well brine cannot penetrate the oiled surface and either "runs off" or "puddles." It is suggested waiting one or two seasons prior to purchasing brine for this type of road.
- 5. Even under normal conditions, it is assumed that dust will not be completely eliminated, and we do not make any promise or commitment to that effect.

# 2022 HTFD Training Report

In 2022 your Highland Township Firefighters performed over 800+ hours of Department provided Fire and EMS Training.

The Training include; Hands on, Lecture, and On-line to ensure compliance with Mandatory MIOSHA and OCMCA requirments.

**Topics for Fire Training included the following**: Ropes, Knots, SCBA, 1<sup>st</sup> due Engine operations, Ventilation, Wildland Search and Rescue, Wildland Fires, Chiansaw operations, Fire hydrants, Water supply, Vehicle Extrication, MAYDAY, Drivers Training, Ladders, Hose advancement, Fire Sprinklers, and Fire inspections.

**Topics for EMS Training included the following**: OCMCA compliance (100%), CPR, documentation, ACLS refresher, Environmental emergencies, Stop the Bleed, OCMCA protocols, Medical Legal, NARCAN administration, Active Shooter, Spinal injuries, Mass Causity incidents, Pediatric emergencies & medication administration.

Highland Township Fire Department was able to secure \$6000.00 in Firework Funds to host a County Wide Leadership Summit presented by Captain Mark VonAppon from California, with over 30 Firefighters from Oakland County.

Highland Township Fire Department participated in over 204+ hours of Mutual Aid Training with the following Departments: Milford, White Lake, North Oakland Fire Authority, Commerce, Springfield, Walled Lake, Novi, Franklin Bingham, Hartland, Brighton. Training consisted of Roof Operations and Search&Rescue at aquired Dairy Queen in Hartland. Water Supply Operations for 1<sup>st</sup> in Engine in Brighton. Toledo Line of Duty Lesson learned hosted by Highland. Emergency Response to Electric Vehicles Presented by ERSI (Emergency Response Soultions International), hosted by Highland Fire. Captain Nick George Grauduated the Eastern Michigan Staff and Command school.

FF/ Paramedic IC Michael Becker earned his Instructor Coordinator License and has taken over as our EMS Coordinator for the Department.

We have 3 FF's currently enrolled in Paramedic School, 2 on Department provided Scholarships.

We had 2 PFF's Graduate the Fire Academy and 3 PFF's Graduate the EMS Academy.

We currently have 3 PFF's attending the Brighton Fire and EMS Academy with graduation in December of 2023.

Along with all the above mentioned training activities our staff continues to improve their skills and training by attending conferences and seminars throughout the State.

The State of Michigan Firefighters Training Council has instituted an Continuation Education Requirement for all Firefighters, which started in October of 2022, as stated in our 2023 Training Plan rest assured that our department will provide all the necessary training for our staff to maintain their level of Firefighter training requirments for the State.

## 2023 Highland Fire Training Plan

**Needs Assessment:** With the new CE requirements from the Firefighters Training Council General Rules and MIOHSA Part 74, the following plan has been developed to provide our staff with training oppurtunities to ensure they meet the requirements. It is imperative that our leaders encourage our staff to be engaged in the training oppurtunites that are provide for them.

**Training dates and times:** Fire 2<sup>nd</sup> Tuesday EMS 3<sup>rd</sup> Tuesday of the month. 1900 hrs to 2100 hrs, Officer will be quarterly date and time TBD. Arrangments have been made with the Milford Fire Department for our staff that can't attend our training; to attend their trainings in Milford (see schedule for dates and times) you will be compensated for training as if you attended our training.

- 1) Firefighters Training Council. R29.418 "Continuing education; requirements."
  - a) Firefighter: Shall complete 36 hours in a 3-year period starting 10/1/2022.
  - b) Fire Instructor: Shall complete 12 hours in a 3-year period starting 10/1/2022.
  - c) Fire Officer: Individuals that hold a Fire Officer certification shall complete 12 hours in a 3-year period starting 10/1/2022.

### 2) MIOSHA Part 74

- a) Bloodborne Pathogen Training
  - i) Initial Training for new employees.
  - ii) Re-fresher Training (yearly).
- b) HAZMAT Review (yearly).
- c) Drivers Training re-fresher Public Act 300 (yearly).
- d) MSDS/SDS Hazcomm Process review (yearly).

- e) Harassment in the workplace (yearly).
- 3) Michigan EMS Continuing Education Requirements
  - a) EMT-B 30 Credits are required in a 3-year period.
  - b) EMT-P 45 Credits are required in a 3-year period.
  - c) I/C EMT-B 30 Credits are required in a 3-year period.
  - d) I/C EMT-P 30 Credits are required in a 3-year period.

- 4) Mandatory OCMCA required training and knowledge assessments: To maintain HTFD's LSA it will be required that all staff complete all OCMCA requirments.

**Delivery Strategies:** Classes will be delivered via an instructor led presentation and hands on practical evolutions. Instructors will be using training materials from JB Learning, IFSTA, Fire Rescue 1 academy, and other related material from topic being taught.

**Selection of Instructors:** High Hazard Training will be under the direct Supervision of a Ceterfied Instructor II, as required under **R.29.410** *"Adoption by Reference"*. Adtionally, Instructors at high hazard training, will be at a minimum level of Certified Fire Instructor I, as required under **R29.410** *"Adopted by Reference"*.

Subject Matter Experts may be used as instructors for trainings that do not fall into the catergory of High Hazard Training.

**Live Fire Training:** All Live Fire will be done in compliance with NFPA 1403. Live Fire Training will be under the direct Supervision of a Ceterfied Instructor II, as required under **R.29.410** *"Adoption by Reference"*. Adtionally, Instructors at high hazard training, will be at a minimum level of Certified Fire Instructor I, as required under **R29.410** *"Adopted by Reference"*.

All Live Fire Training will have a documented NFPA 1403 burn plan completed prior to the state of training.

**Contingency Planning for Delivery Interruptions:** Should there be an interruption in the delivery of materials, the instructor will have slides and lesson plan printed in advance. The instructor will be able to use the dry erase board with the provided Expo markers to jot down key notes, should there be a projector failure.

**Documentation of Training:** The training will be documented using HTFD Training attendance sheet. A copy will be scanned and emailed to the BC in charge of Training. Paper copy will be delivered to Assistant Chief for payroll purposes.

**Course Evaluation:** Following completion of training, participants will complete a course evaluation form. Course evaluation forms are key to the development of our Instructors and to improve our training program. Course evaluation forms will be scanned and emailed to the BC in charge of Training, after scanning, forms are to be shredded.

**Training Records:** Training records will be kept in accordance to HTFD Records Management policy # 800.

**Training Schedule:** A copy of the master 2023 Training Schedule is attached to this document. A printed copy will be posted quartly at both Station #1 and #2. The schedule is subject to change based on business need, weather delay, etc.

**Standards:** The course shall be delivered within NFPA 1041 Job performance requirements for Fire Instuctor I. The courses shall meet the JPR's defined in the NFPA 1041, 1021, and 1001.

**References:** NFPA 1041:4.1.1 (Roles and Responsibilites of the Fire and Emergency Services Instructor, NFPA 1041:4.4.2 (Physical elements of learning environment), NFPA 1041:4.2.5 (Importance of proper record keeping), NFPA 1001, (Standard for FireFighter Professional Qualifications).
